What is ECoP® an acronym for?

Export Compliance Professional



What are the benefits of ECoP® Certification?

- ECoP® Certification shows that your organization's trade compliance professionals can apply complex export regulations correctly to a high standard.
- Passing the ECoP® Certification test(s) requires the ability to analyze the regulations and apply them in scenarios that would reflect real-life compliance challenges.
- ECoP® tests are developed by the experts at ECTI who have experience in both the US Government and private industry perspectives on export controls. The tests are designed to test knowledge and be a reliable predictor of an individual's ability to understand and apply the regulations.
- Investment in ECoP® Certification can be a powerful indicator to the US Government of your organization's commitment to keeping your key personnel up-to-date and knowledgeable on the current state of export regulations.
- ECoP® testing can be a valuable tool for identifying areas of relative compliance knowledge weakness where your training resources can be focused.



Is there more than one type of ECoP® Certification?

Yes, one can become certified in either or both of the following types:

- ECoP® ITAR
- ECoP® EAR



How do you begin the certification process?

Participate in one of the following comprehensive training courses from the Export Compliance Training Institute (ECTI):

1. EAR/OFAC Export Controls

What is the difference in training for US and non-US organizations?

ECTI offers comprehensive training on United States export control regulations administered by the US Departments of State (ITAR), Commerce (EAR) & Treasury (OFAC).

US Export Controls apply differently to US organizations and organizations not physically located in the United States. We have developed training for both groups and the primary difference between the two is the perspective.

Training for non-US companies will look at the regulations in depth, specifically as they apply to an organization physically located outside of the United States.

Training for US companies will also have a section on Reexports, which explores the regulations as they apply outside of the United States, but that is not the focus of the entire training.

*****A company located outside of the United States will benefit most from our training developed for non-US companies/organizations.***



What is the next step in certification after comprehensive training?

- The ECoP[®] test is emailed to you after completion of the course (Adobe PDF format).
- The test is an application-style, open book test consisting of questions and scenarios that one would encounter in the real world of export compliance.
- You may use your seminar manual or e-Manual (provided with live seminar training and e-Seminar training), the regulations, and any other resources you may find helpful. You are restricted from getting assistance from another person. You must complete the test on your own.
- You have 60 days to take the test after a live training and 180 days from the receipt of e-Seminar electronic training.
- Each test (EAR or ITAR) consists of 50 multiple choice and/or short answer questions.
- You must receive a score of 85% correct or greater in order to be certified for the ECoP[®] test that you take.



What if I score lower than 85% on the ECoP® test?

- If you score lower than 85%, we will tell you which question(s) you missed so that you can focus on areas that you may not have understood completely.
- You will have 30 days from receipt of your results of your first test to take the test again, one time, at no extra charge.
- Additional testing beyond that will be at US\$100.00 per test.



What happens after I pass the ECoP® test(s)?

- After passing the test, you will be mailed a certificate indicating your name, certification type, and period of certification validity.
- Certification is valid for a period of 2 years from course completion.
- Certification is renewed based on the completion of 4 credits per ECoP® Certification (EAR or ITAR) prior to the certification expiration date.



How do I renew my ECoP® Certification(s)?

- Certification is renewed based on the completion of 4 credits per ECoP® Certification (EAR or ITAR) prior to the certification expiration date.
- ECTI's ECoP® Certification is valid for 2 years following your last day of training for a live seminar or e-Seminar. Renewal certification periods will extend 2 years from your current certification expiration date. Certification can not be renewed more than 24 months prior to expiration date. Renewal training is necessary before your certification expires.
- The following credits are required to keep your certification(s) valid:
 - ECoP® EAR: 4 EAR Renewal Credits
 - ECoP® ITAR: 4 ITAR Renewal Credits



How can I earn renewal credits?

1. The simplest way to renew is to register for the relevant ECTI course(s) before your certification expiration date.
 - ECTI approved renewal courses
 - Comprehensive training via live seminar or e-Seminar (EAR/OFAC or ITAR)
 - Trade Controls Webinars from ECTI library of 60+ live and on-demand webinars
2. You can also renew your certification by attending a pre-approved, relevant Bureau of Industry and Security, United States Department of Commerce (BIS) course, a pre-approved, relevant Society of International Affairs (SIA) course, or a pre-approved AUECO course.
